Notice is hereby given that a quorum of the Blue Ridge City Council and Blue Ridge Economic Development Corporation Board may be in attendance at this meeting of the Blue Ridge Community Development Corporation Board

1. Call BRCDC meeting to order and announce a quorum is present.
2. Roll Call
3. Public Comment: This is an opportunity for the public to address the Board on any matter included on the agenda, except public hearings. Comments related to public hearings will be heard when the specific hearing begins. Public comments are limited to three (3) minutes per speaker, unless the speaker requires the assistance of a translator, in which case the speaker is limited to six (6) minutes, in accordance with applicable law. To address the Board, speakers MUST complete a Speaker Form and provide it to the Board Secretary PRIOR to the start of the meeting. Each speaker shall approach the front of the Board and state his/her name and street address before speaking. Speakers shall address the Board with civility that is conducive to appropriate public discussion. The public cannot speak from the gallery but only from the front of the Board. Per the Texas Open Meetings Act, the Board is not permitted to take action on or discuss any item not listed on the agenda. The Board may: (1) make a statement of fact regarding the item; (2) make a recitation of existing policy; or (3) propose the item be placed on a future agenda, in accordance with Board procedures.
4. Discuss, approve or disapprove Minutes from: March 29, 2021. Meetings were not held in April 2021, May 2021 and June 2021.
5. Discuss, approve or disapprove Financials from: March 2021, April 2021, May 2021, June 2021
6. Discuss, approve or disapprove opening and awarding mowing bids or opting to open a new bid with different bidding parameters
7. Discuss, approve or disapprove other Bratcher Park projects including, but not limited to, a canopy, lighting of the park, cameras to protect the investment of the park, painting, parking lot, sidewalk and further park enhancements
8. Receive update regarding the Downtown Revitalization Grant

9. Discuss, approve or disapprove Stimulus recipients and those whose loans should be cancelled by sending 1099-C forms
10. Discuss, approve or disapprove planning for Fall Festival to include setting the date and other arrangements for this event

13. Adjournment


Items marked with an asterisk () are consent items considered to be non-controversial and will be voted on in one motion unless Board Member ask for separate discussion.

When called upon, the person should come to the front of the meeting, **state his or her name and address for the record,** and if speaking for an organization or other group, identify the group represented. **All remarks are to be addressed to the Board as a whole and not at individual members.** The presiding officer shall determine whether, or in what manner, any response will be provided.
