**Commissioner Whitaker seconded the motion. Motion carried unanimously.**

**1. Public Hearing**

**A motion was made by Commissioner Whitaker to go into the Public Hearing.**

**Commissioner Harper seconded the motion. Motion carried unanimously.**

- A. Amendment of Flood Damage Prevention Ordinance- Ronnie Locke informed that every four to five years the state requires that town to submit a map of the projected flood areas around Enfield. There had no changes in that flood areas on the map since that last time it had to be submitted. Mr. Locked asked is the board would vote to submit to add all revises there to in the amended section of the Flood Damage Prevention Ordinance. Commissioner Whitaker asked about the area of McGwigan where the apartments are because he can remember with a hurricane that came through the floor waters almost covered the roof. Mr. Locke informed that they so not consider the result national disasters as a flood area. Commissioner Ward asked for a digital copy of the flood map so he could post it for public view on the town's

website. **A motion was made by Commissioner Ward to close the public hearing. Commissioner Whitaker seconded the motion. Motion carried unanimously. A motion was made by Commissioner Ward to go back into the public hearing. Commissioner Harper seconded the motion. Motion carried unanimously.**

- B. Applying for FY 25/26 CDBG NR Funding- Elisabeth Raskopf informed that this was the second required public hearing for the town to apply for Neighborhood Revitalization Grant in the amount of \$5,000,000.00. Housing Revitalization Funds not to exceed \$950,000.00, properties for replacement are 720 Nustreet Rd, 113 E. South St, 108 Mason St. Houses for rehab are 115 E. South St and 105 E Alsop St. The alternates are replacement or rehab are 342 Taylor St, 515 N MLK Ave, 107 W Alsop St, 214 N MLK St, 217 Bass Ln, 509 SE Railroad St, and 505 E Franklin St. Under the Rural Community Development Fund, is sewer main replacement/ rehabilitation and pump station replacements and repairs, not to exceed \$4,050.000.00. Locations to be included are sewer main replacement/ rehab Nash St, (Cook St to Glenview Rd), SE Railroad St (Burnette Ave to South St) Randolph St and Austin St (SE Railroad St to the dead end on Austin St). Pump Station Replacements- Pump Station #1 & #4, and pump stations for repairs #2, #5 and #9. There were no comments from the public. Mayor Robinson informed that addresses that were called were not new applicants but were previously selected in the last grant but he erg everyone to apply for future funding. Commissioner Whitaker announced that he had received calls about the inspectors coming to inspect or reinspect the selected houses and some were in worse shape than they were the first time. Public Hearing minutes were adopted at meeting that day. **A motion was made by Commissioner Whitaker to close the public hearing. Commissioner Ward seconded the motion. Motion carried unanimously.**

## **2. Presentation**

- C. Resolution for Applying for CDBG Funding-Elisabeth Raskopf informed the resolution was to allow the town to submit the application for the CDBG grant funding. **A motion was made by Commissioner Ward to adopt that Resolution to apply for CDBG Grant. Commissioner Whitaker seconded the motion. Motion carried unanimously.**
- D. **A motion was made by Commissioner Ward to adopt the minutes from the CDBG Public Hearing. Commissioner Whitaker seconded the motion. Motion carried unanimously.**
- E. Monthly Grant Reports- Elisabeth Raskopf provided that monthly grant reports that included submitting engineering reports to the stated and having surveys completed.

## **3. Departmental Reports**

- A. Planning & Zoning- Ronnie Locke provided that Planning and Zoning report that included locating properties with back taxes. Mr. Locke informed that he had located 30 properties with back taxes the number included businesses. Mayor Robinson asked

informed that the town needed to get the engineer to design for the entire grid so that the design could be included in the RFP that would be sent out. Mayor Robinson reiterated the importance of get the design for the grid and how it would help in the renegotiation and the knowledge of what houses are connected to which circuit when there is an outage. The system is outdated he spoke with someone that stated they worked with the town back in the 1980's and the system is still the same. Mrs. Whitaker announced that the insurance would not cover the design portion of the entire grid but the town needed to go ahead and get that part done so that the quotes for upgrading of the system would be accurate. After a brief discussion on where the funding for \$42,000.00 would come from for the engineer to design the entire grid. **A motion was made by Commissioner Ward to use \$42,000.00 of the funds set aside for a Community Center to have the entire electric grid designed by engineer. Commissioner Harper seconded the motion. Motion carried unanimously.** Mayor Robinson asked if the rest of the funding could be placed in a high earning account. Mrs. Whitaker stated only if we could access the funds without being penalized.

- D. Parks & Rec- was in board package to board review
- E. Electric Dept- Delton Silver provided Electric Dept report that included getting information to engineer to upgrade grid.
- F. Public Works -was in board package to board review

**G. Administrative Matters**

- A. Commissioner Report- Commissioner Whitaker announced that First Baptist would be handing out supplies on the following day from 2pm until supplies are gone. He also asked that citizens to stop trying to create a problem with the board members. There isn't an issue with him and the mayor. They may not agree on everything, but they are still friends. Commissioner Ward expressed his feelings about what people were saying when it came to the mayor and other members of the town board as well.

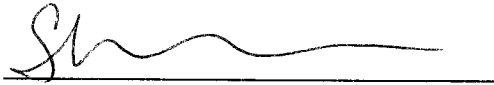

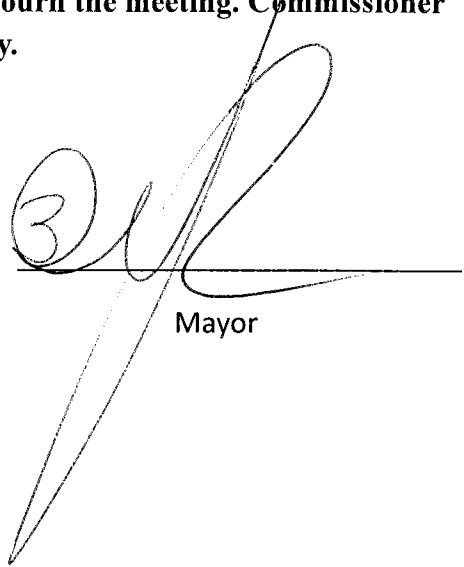

Mayor Robinson introduced Elisabeth (Liz) Raskopf, Community Development Manager, with the Upper Coastal Plain Council of Governments, who read the following statement:

The purpose of this public hearing is for City Council to receive comments on the City's intention to apply for the 2025-2026 Community Development Block Grant – Neighborhood Revitalization grant program due October 29<sup>th</sup>. This is the second of two public hearings that are required to apply.

The activities to be included in the application are to-fold.

First, under the Neighborhood Revitalization program is "Housing Rehabilitation" in an amount not to exceed \$950,000. The Housing Selection Committee met and reviewed pre-applications, which included income and needs surveys. Based on the eligibility criteria, the application will include the following properties as the three primary beneficiaries and two alternate beneficiaries. The committee affirmed that Priority List will be included in this order:

- Commissioner Redic- Park Dr. stated that he did not see the fence as a barrier just for safety.
- Commissioner Joyner- Busbee Ct. stated that the fence is for safety it should stay.
- Commissioner Whitaker- Liberty St. agreed with Commissioner Joyner the fence is for safety.
- Commissioner Ward stated his kids are grown but we should have the kids that play at the cage in like animals. And it would be good to hear from those who stated across from the park.
- Joynel Whitaker- W. Bryant St. asked how would they keep the YNs (as the young people call them) away from the kids to keep them safe if the fence is gone.
- Commissioner Whitaker assured that there are enough officers and the Halifax County Deputies to keep someone the area to patrol often.
- Mayor Robinson stated that is where the community steps in to say this is our park and we want to keep it safe and clean.
- Commissioner Redic informed that there have been a few incidents where he was entering it church on McDaniel St. there were some young men hanging around the Smoke Shop smoking weed, he kindly asked them to not smoke near the church especially weed since it is illegal or he would be force to contact the property owner and report the Smoke Shop.
- Mary Harrison. Week St. stated that the Smoke Shop was not the issue. The people that are up there reside at the Carriage House Apartments.
- Joynel Whitaker stated that is what she was referring to if the fence is removed it would give those people more access to the park.

## **2. Presentation**

Public Works- Michael Powell provided the important activities for Public Works, he informed that biggest project was installing the bridge at the cemetery, the installation was completed on September 4<sup>th</sup>. The other project was to get the streets prepared for paving and patching was completed on August 27<sup>th</sup>.
- B. Planning & Zoning- Ronnie Locke provided the planning and zoning report that included marking off graves,
- C. Police Dept.- Captain Field informed that the police department had 2 new applicants that was the only new thing.
- D. Finance Dept & Town Administrator Report- Patricia Whitaker provided the utility billing that included electric \$241,177.92, sales taxes \$15,110.67, rep fess, -\$1072.66, garbage \$21012.00, water \$58,433.44 and sewer \$55,874.32 totaling \$390,535.69. There were 55 rereads 10 electric and 45 water.
- E. Parks & Rec- Nikkita Jones asked for more engagement from everyone, she announced that the library will start their STEM program the following. She also informed that on the 25<sup>th</sup> NCCU Hub will be administering flu shots and on the 27<sup>th</sup> the NCCU Hub will have a men day from 10am to 1pm.
- F. Electric Dept.- Lonnie Highsmith informed that he has spoken with contractors about hanging and the feeder switch to put the station back. And he also obtained the price to upgrade circuit 6 to 7200 and also order 15 flood light for the basketball area at the parks and rec.

**G. Administrative Matters**

- A. Commissioner Report-Commissioner Ward stated it is a waste of energy for negativity. But your focus should be on what is good for the town. He loves this town. If you question that you are crazy. He could be anywhere he chooses to be here.

Mayor Robinson thanked the Peanut Festival committee for there hard work and suggested that continue working towards next years festival.

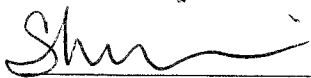

The purpose of this hearing will be to receive input from Town Citizens on the completed activities and accomplishments of the Town's Key Street Drainage Project Community Development Block Grant – Neighborhood Revitalization (CDBG-NR) Grant 18-C-3072. Under this program, the NC Dept. of Commerce awarded the Town of Enfield a total of \$719,250 for CDBG-NR Funding to finance the project.

The activities, as listed in the grant application, consisted of Drainage Improvements on Key Street and the rehabilitation/ reconstruction of up to 3 homes. These homes were located on Branch Street, Dennis Street and Railroad Street. All of the Drainage Improvements work was completed as stated. One home was completed, and the homeowner has moved into her home. No other homes were able to be completed with this grant for various reasons, including ownership issues and income limit threshold issues.

The Board was directed to refer to the Closeout Accomplishment and Certificate of Completion forms, where it was explained that there were three budgetary activities within this grant. They were grant administration, Flood & Drainage Improvements, and the rehabilitation of private dwellings. The bulk of the funds were expended on the housing rehab and flood & drainage activities of the grant.

It was further pointed out that the Certificate of Completion form shows the total amounts expended during the project as \$493,704.00 and the bottom section shows the total amount awarded, \$719,250.00, and the amount "unutilized" of \$225,546.00, which was deobligated.

There were no comments from the public.

**A motion to approve the program amendment was made by Commissioner Whitaker. Commissioner Joyner seconded the motion. Motion carried unanimously.**

Mayor's report- he would like to see more lights at the Parks. He would like see the fence removed from the Parks and Recreation off of Hwy 301. Commissioner Whitaker stated it would be a good idea to get the citizens input on this. Mayor stated it will be a Public Hearing at the September Board meeting to address the fencing around the park. The mayor expressed, the board seats shouldn't be about if you like the person, but if that person can handle the position at hand. The folk need to use their voices to bring about change on how the Federal government view small towns/rural spaces.

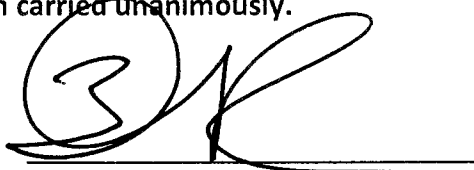

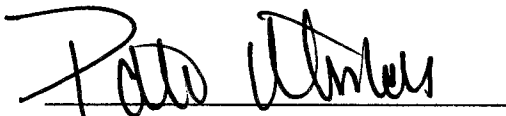

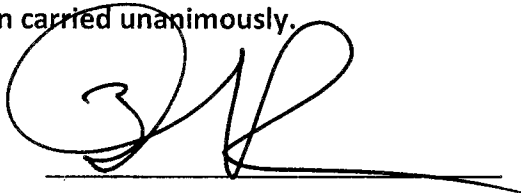
