WHAT IS HOUSEHOLD HAZARDOUS WASTE?

Household hazardous waste (HHW) are products found around the home that are considered:

- flammable
- toxic
- corrosive
- reactive

The average home can accumulate as much as 100 pounds of HHW per year. HHW can be found in all areas of the home including the kitchen, bathroom, garage, workshop, and garden area.

WHY COLLECT HOUSEHOLD HAZARDOUS WASTE?

Certain types of Household Hazardous Waste (HHW) have the potential to cause physical injury to sanitation workers, contaminate septic tanks or wastewater treatment systems if poured down drains or toilets. They can also present hazards to children and pets if left around the house. If disposed of improperly, household hazardous waste can contaminate:

- air
- soil 💠
- surface water
- ground water
- wastewater treatment systems
- septic tanks

WHAT CAN YOU DO TO BE SAFE?

- Use and store products containing hazardous substances carefully to prevent any accidents at home.
- Never store hazardous products in food containers.
- Keep products in original containers and never remove labels. Corroding containers, however, require special handling. Call the Kearney Area HHW Collection Center or the Fire Department for instructions.
- When leftovers remain, never mix HHW with other products. Products that are incompatible might react, ignite, or explode.
- Remember to follow any instructions for use and disposal provided on product labels.

Landscape/Yard Fertilizer, lawn care, swimming pool products, and more...



Home Maintenance Paint, stain, varnish, paint thinner, stripper, adhesive, and more...

- Ammunition and explosives
- Asbestos
- Fire extinguishers
- Electronics
- Radioactive materials
- Fluorescent lights, ballasts,

capacitors
