Sealed Bids will be received at the Office of the City Clerk, Rachel Wrather, 301 East Main Street, PO Drawer B, Portageville, MO 63873-0340 until noon, on Friday, July 29, 2022.

All Bid Proposals must be placed in an envelope, sealed, and clearly marked on the outside: "Bid for Resurfacing City of Portageville Streets."

Sufficient proof of liability and worker's compensation insurance must be furnished to satisfy requirements of the City of Portageville if your bid is selected.

When required by State Law, please be advised that all Bids must comply with the Missouri Prevailing Wage Act and Prevailing Rate of Hourly Wages in the City of Portageville where the Work is to be performed is to be paid to all persons on the project.

The successful respondent shall comply with all codes, ordinances, rules, statutes, laws and regulations of the City of Portageville, State of Missouri as they apply to all Public Works construction projects. Please be advised that if the bidder has not previously done asphalt work with the City of Portageville, references and examples of completed work with other municipalities is highly encouraged.

A Council Meeting will be held on Monday, August 1, 2022 at 6:00 p.m. to unseal and review proposals and select the most highly advantageous proposal.

The City of Portageville reserves the right to reject any or all Bids, or parts thereof, and to waive any technicality, informality or irregularity in the Bid received, and to disregard all nonconforming or conditional Bids or counter-proposals and to hold the best bids for ninety (90) days from the opening date set forth above. The City of Portageville reserves the right to award the Bid to the lowest responsible Bidder whose offer best responds in quality, fitness and capacity to the requirements of the proposed Work or usage and therefore is in the best interest of the City.
