CITY OF PORTAGEVILLE QUESTION

Shall the City of Portageville, Missouri, issue its combined waterworks and sewerage system revenue bonds in the amount of up to Seven Million Dollars (\$7,000,000) for the purpose of acquiring, constructing, improving, extending, equipping and furnishing the City's combined waterworks and sewerage system, including the acquisition of real estate and easements related thereto, the cost of operation and maintenance of said system and the principal of and interest on said revenue bonds to be payable solely from the revenues derived by the City from the operation of its combined waterworks and sewerage system, including all future extensions and improvements thereto?

Summary

The authorization of the bonds will authorize the City to fix, establish, maintain and collect rates and charges for the services provided by the City through its combined waterworks and sewerage systems, including all extensions and improvements thereto hereafter constructed or acquired by the City, in addition to the other rates and charges for such services provided by law, as will produce income and revenues sufficient to provide funds to pay the costs of operation and maintenance of said combined waterworks and sewerage system and the principal of and interest on said bonds as they become due and to retire the same within thirty-five years from the date thereof, and to provide for the establishment of reasonable reserves therefor.
