That part of the east-west alley that lies between and abuts Lots Numbered Three (3), Four (4), Five (5), Six (6), Seven (7) and Eight (8) and the north-south street that lies east of Lots Numbered Three (3) and Eight (8) and west of Lots Numbered Four (4) and Seven (7) in Myers' 1<sup>st</sup> Addition of the Original Plat of the Town of Kirklin, as the same is recorded in Plat Book 2 (new), Page 221.
