- 1. To meet the requirements: You must have a Texas Driver's License, have not taken the class within the last 12 months, not speeding 25 mph or more over the speed limit.
- 2. Request DSC at court appearance, by calling, or mail.
- 3. Pay \$144 by phone, in person, mail, online
- 4. Submit a copy of your proof of liability insurance.
- 5. Submit a copy of your Texas Driver's License
- 6. Provide the Court with your driving record, this must be done prior to taking the Driving Safety Course (DSC). You can obtain your driving record from Texas DPS at <a href="www.dps.texas.gov">www.dps.texas.gov</a> or by calling 512.424.2000. You can also pick up an order form (DR-1) at your local DPS Driver's License office.
- 7. Once you have completed the course you must submit a signed certificateof completed.
