1. Must obtain a Food Permit from the Cameron County Public Health office, if you will be selling certain food items. For more information Call (956) 247-3685 or go to 1390 W. Expressway 83, San Benito, TX 78586.
2. Food Permits must be Visibly Displayed at your booth, to avoid any fines or being asked to close your booth and vacate the booth premises.
3. Registration Fees are Non-refundable.
4. Vendors must provide their own booth structures and must set-up within the assigned booth space paid. If booth size requirement is not met, an Oversize Fee will be charged and may be relocated.
5. Set-up Arrival Time will begin at 12:00 p.m. through 3:00 p.m.
6. You must arrive at your designated Booth Area on time, or you may be relocated. 7. No music is allowed in booths.
8. Must follow all City/State/Federal rules, guidelines, laws, ordinances.
