- (3) Public Comments: Any citizen with business not scheduled on the agenda may speak to the City Council. Prior to speaking, each speaker must be recognized by the Mayor. The council may not discuss or take any action on an item but may place the issue on a future agenda. The time allowed per speaker may be limited.**
- (4) Approval of the minutes of the previous meeting(s).**
- (5) Approval of financial report and City expenditures.**
- (6) Consider and possible action regarding Montgomery County Emergency Communication District Board of Managers Appointment to Represent Municipalities.**
- (7) Consideration and possible action regarding a resolution approving the Montgomery County Emergency Communication District Budget for Fiscal Year 2026.**
- (8) Consideration and possible action regarding changing telephone and internet services from Consolidated Services to Optimum Fiber. Jon Buice with Trueway IT will be present to speak with council regarding the matter.**
- (9) Consider and possible action regarding calling special election for November 04, 2025 with Montgomery County, to fill vacancies for the City of Cut and Shoot place on the ballot.**
- (10) Consider and possible action to approve all paperwork associated with holding the special election.**
- (11) Consideration and possible action regarding ongoing engineering matters.**
- (12) Consider and take action, if deemed necessary on report from A-1 Utility & Construction regarding operations in the water system.**
- (13) Consider and take possible action, if deemed necessary, on report of Police activities.**
- (14) Hear comments from the mayor and city secretary.**
- (15) Adjourn.**

If, during the course of the meeting and discussion of any items covered by this notice, City Council determines that a Closed or Executive Session of the Council is required, then such closed meeting will be held as authorized by Texas Government Code, Chapter 551, Section 551.071 – consultation with counsel on legal matters; Section 551.072 – deliberation regarding purchase, exchange, lease or value of real property; Section 551.073 – deliberation regarding a prospective gift; Section 551.074 – personnel matters regarding the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; Section 551.076 – implementation of security personnel or devices; Section 551.086 – deliberation regarding competitive matters of a public power utility ; Section 551.087 – deliberation regarding economic development negotiation; and/or other matters as authorized under Texas Government Code. If a Closed or Executive Session is held in accordance with the Texas Government Code as set out above, the City Council will reconvene in Open Session in order to take action, if necessary, on the items addressed during Executive Session.
