

**AN ORDINANCE TO AMEND SECTION 720.040 (PARAGRAPH C) (CHAPTER 720)  
SEWER USERS CHARGE OF THE MUNICIPAL CODE OF THE CITY OF  
GRANBY.**

Be it ordained by the Board of Aldermen of the City of Granby as follows:

Section 1. That Section C is hereby repealed in its entirety and a new Section C is hereby enacted in its place to read as follows:

**SECTION 720.040 USER CHARGE RATES**

C. The minimum charge per month for the collection and treatment of sewage shall be 35 dollars and 81 cents (\$ 35.81) for the first (1<sup>st</sup>) one thousand (1,000) gallons for residential contributors and 35 dollars and 81 cents (\$ 35.81) for the first (1<sup>st</sup>) one thousand (1,000) gallons for nonresidential contributors. In addition, each contributor shall pay a user charge rate of 3 dollars 80 cents (\$ 3.80) per one thousand (1,000) gallons of water (or wastewater) above the minimum as determined in the preceding Section. This sewer charge will be in effect beginning May 2025 billing cycle.

This ordinance shall take effect and be in full force and after its date of passage, the same being determined by the Board of Aldermen of the City of Granby.

**AN ORDINANCE TO ADD SECTION 705.150 (PARAGRAPH B) (CHAPTER 705) WATER USERS CHARGE OF THE MUNICIPAL CODE OF THE CITY OF GRANBY.**

Be it ordained by the Board of Aldermen of the City of Granby as follows:

**SECTION 705.150 RATES AND CHANGES**

B. The rate for water service to customers of the waterworks system of City of Granby, Missouri, shall be as follows:

First 200 cubic feet or 1,496 gallons \$24.62 Minimum

Next 2000 cubic feet or 13,458 gallons \$ 0.01 per CF or \$.00147502 per gal.

Over 2200 cubic feet or 14,962 gallons \$ 0.007 per CF or \$.0007364706 per gal.

This water rate will be in effect beginning the February 2026 billing cycle.

This ordinance shall take effect and be in full force and after its date of passage, the same being determined by the Board of Aldermen of the City of Granby.
