- _____ 1. The Adopter(s) agrees to pay the current adoption fee of \$_____. The animal will be spayed and neutered before the Adopter(s) takes possession of the animal (if applicable). In the event of a puppy/kitten adoption, an appointment will be made by the Adopter(s) and confirmation of the appointment will be received by the Shelter, before the Adopter(s) takes possession of the puppy/kitten. Documentation from the veterinarian, confirming the date that the animal has been spayed or neutered, must be received by the Shelter within ten (10) days of the appointment date on file. Shelter staff must be advised of any changes or cancellation of the date to spay or neuter.
- _____ 2. The Adopter(s) will provide proper and sufficient food, water, shelter and kind treatment for the animal. The Adopter(s) agree to keep the animal as a companion and not allow the animal to be used for medical experimentation or criminal purposes, i.e. dog fighting.
- _____ 3. The Adopter(s) agrees to seek regular care from a licensed veterinarian for examinations and immunizations and understands they will be responsible for all costs incurred for those services.
- _____ 4. The Adopter(s) will license the animal in accordance with State law and the ordinances of the City of Waynesville if living within the City of Waynesville.
- _____ 3. The Adopter(s) are fully aware that the City of Waynesville, Missouri makes no guarantee as to the health, temperament, mental disposition or training of the animal.
- _____ 8. The Adopter(s) hereby fully and completely releases the City of Waynesville, it's agents, servants and employees from any liability regarding defects or illness the animal may have or develop and from any claims or cause of action for any injury of or damage to persons property which may be caused by the animal and to indemnify and hold the City of Waynesville harmless against all claims, including but not limited to, those asserted by third party persons for any injury or damage to persons or property caused by the animal. This agreement shall be governed by the laws of the State of Missouri and the ordinances of the City of Waynesville.
