Leave your worries behind and enjoy the outdoors at Waynesville's Roubidoux Springs Campground. The campground is located on Historic Route 66 on the banks of the beautiful Roubidoux Creek. You'll find quiet seclusion just steps from shopping and restaurants. We believe this is the best of both worlds. RV and tent campsites are available.

SITE INFORMATION

Please call City Hall, Monday thru Friday 8am to 5pm in order to reserve your space. If you will be arriving after 5p.m. or over the weekend, please contact City Hall prior to your arrival during normal business hours in order to ensure a reservation for your vehicle and/or camp site as Park staff may not be reachable as they only respond to emergencies after hours or on the weekends.

Back-In Gravel

Parking for your RV or Trailer is 18' wide and 50' long with a minimum of 10' of grassy area located on both sides of the parking space for your enjoyment.

Water, sewer and 20-30-50 amp services are available. Parking for additional vehicles is limited to two (2) vehicle(s).

Pull-Through Gravel

Parking for your RV or Trailer is 18' wide and 58' long with a minimum of 10' of grassy area located on both sides of the parking space for your enjoyment.

Water, sewer and 20-30-50 amp are services available. Parking for additional vehicles is limited to two (2) vehicle(s).

RATES

Rates are calculated per night, normally for 2 adults and children 12 years or under that are staying in the same RV or tent. Payment is due at the time of check-in. This includes any outstanding balance on reservations. All renters must have proper paperwork in hand if checking in to the park after normal business hours. Check out time is 11:00a.m.

Payment can be made by cash, check, money order or a debit/credit card. Debit and Credit Cards are charged a 2.5% convenience fee for processing and may only be processed over the phone or at City Hall during normal business hours. Guests of the Campground have full access to the following:

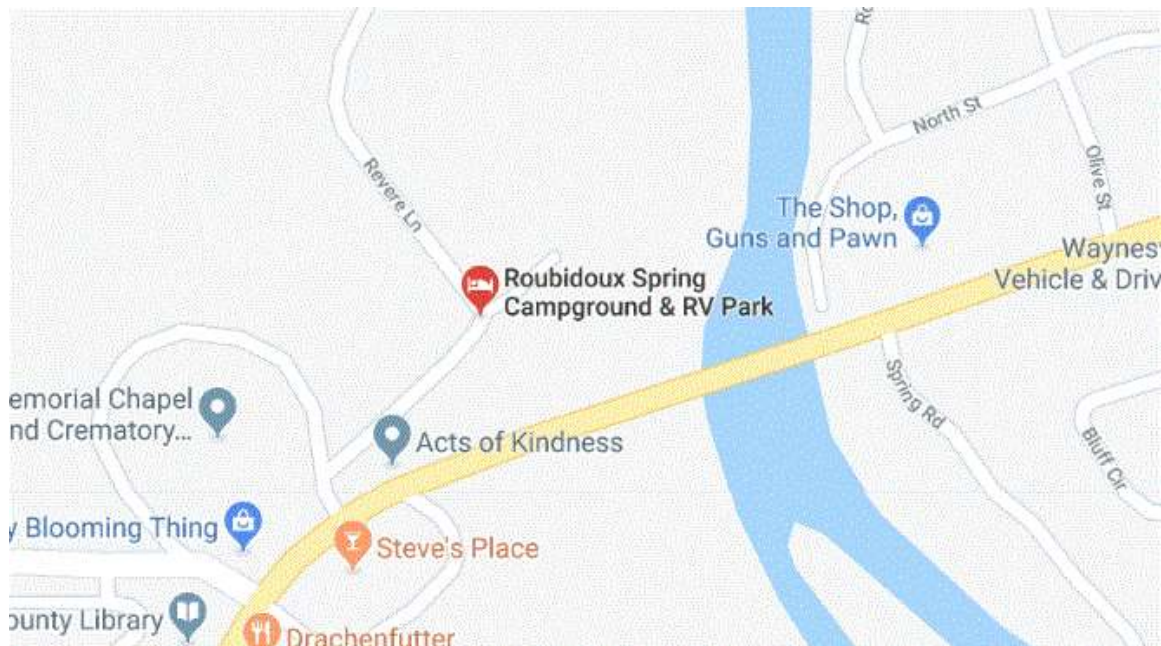
- Shower/bathroom facilities.
- The Roubidoux Creek, a State of Missouri Conservation Trout Release Point.
- A walking trail that travels through the Roubidoux Park and through downtown Waynesville.
- Spray Park located within walking distance in the Roubidoux Park.
- Swimming and spelunking in the Roubidoux Spring located within walking distance in Laughlin Park.
- Access to the Trail of Tears Memorial.
- Pulaski County Farmer's Market – Saturdays Only.

Take Exit 156 off of I-44 – **East bound exit**, turn left & cross the overpass, **West bound exit**, turn right, then go to the traffic light at Ichord & Historic Rt. 66. Turn right. Go approximately 2 miles & you will see Pulaski County Public Library on left hand side then Waynesville Memorial Chapel. You will see a sign for the Roubidoux Springs Campground on the left. Turn left at the sign & follow the road back to the campground.

NOTICE TO ALL CAMPERS AT THE ROUBIDOUX SPRINGS CAMPGROUND

Please be aware that you are camping very near a stream. During periods of extended rains, the Roubidoux stream can and will flood the campground. **Some of these floods have carried campers downstream.**

While you are camping here it is of the utmost importance that we have a phone number to be able to contact you at all times during the day and night. **Please fill out your contact information completely.**

All RV's/campers must be in good working order. No RV/camper will be allowed to remain on site and in the park if it is inoperable and unable to be removed, on its own, in case of emergencies.

If you are going to leave the area and leave your camper here, make sure that there is someone you know that can remove your camper for you in case of a flood. Note this person's contact information on the emergency contact portion of your application. **This person should be within 30 minutes response time of the campground due the potential of rapidly rising waters during flooding events.** If you do not have anyone that can remove your camper for you, we suggest you do not leave your camper unattended while you are out of the area for an extended time period. **The City of Waynesville is not responsible for removing your camper during times of flooding.**

It is important for you to understand that you will be responsible for any costs associated with recovering your camper and any fines assessed by the Department of Natural Resources (DNR). The City of Waynesville is not liable for any damages that may occur to your camper due to acts of nature during extreme weather events.

Contact information for the Park Superintendent is intended for emergency situations only after business hours. Please do not call the Superintendent's number to make reservations for the RV Park after 5pm Monday thru Friday and weekends.

Rules & Regulations

PLEASE ABIDE BY THE FOLLOWING CAMPGROUND RULES AND REGULATIONS:

Pets: All pets must remain under control & supervision of the owner. Pets will not be chained or tied to trees or any campground fixture. Owners must be present when animals are outside. Cleaning up after your pets is strictly enforced.

Guests: Campers will take full responsibility for the actions of their guests in the park. All campers and guests should practice good camping manners.

Conduct: Disorderly conduct, vulgar language or the use of illegal drugs will not be tolerated. All federal, state and local laws will be obeyed at all times.

Quiet Hours: Please respect other campers. Quiet hours are 10:00p.m. to 7:00a.m. daily. The Roubidoux Campground is closed to non-campers after 10:00 p.m.

Camp Fires: Small campfires, due to location & to burning conditions, are allowed only in the fire rings that are provided by Park staff, and at the Park's discretion. No household trash or aluminum cans are to be burned in the metal grates.

Campsite Cleanliness: Please keep your site clean by bagging and disposing trash at the dumpsters provided at the entrance to the campground. Removal of dirt, limbs, vegetation & wildlife is prohibited, forbidden & against the law. A minimum clean up fee of \$25.00 may be assessed at the time of check out for any trash or debris that is left by the guest at their site.

DUMPSTER IS FOR HOUSEHOLD TRASH ONLY. NO ANIMAL PARTS (CLEANING OF FISH) IS ALLOWED TO BE DISPOSED IN THE DUMPSTER.

Alcoholic Beverages: The consumption of alcoholic beverages is permitted at your campsite by legal adults only. Public drunkenness or loud, disruptive behavior may result in arrest & removal from the campground.

Showers/Restrooms: Men's and Women's heated facilities are available along with an ADA accessible shower and bathroom. Electrical outlets are provided for your use.

Stream Fishing: Stream fishing is governed by the regulations of the Missouri Department of Conservation. A Missouri fishing license as well as a Trout Stamp is required and available through local vendors.

Please report any problems with the restroom or shower facilities, equipment, or other guests during your stay to any City of Waynesville Park Employee or the Park Superintendent, Trey Haragan, at (573) 528-8706.
