**ORDER OF THE COUNTY JUDGE OF RAINS COUNTY, TEXAS
CALLING A SPECIAL ELECTION FOR THE CITY OF POINT**

**THE STATE OF TEXAS
COUNTY OF RAINS**

WHEREAS, three simultaneous vacancies exist on the governing body of the City of Point, Texas, as a result of the resignations of Councilmembers Donna Jones, Ray Lacy, and Kim Edwards, which resignations were received by the City of Point on December 10, 2025, and became effective on December 19, 2025; and

WHEREAS, the existence of these vacancies prevents the City of Point from conducting municipal business with a functioning governing body; and

WHEREAS, taxpaying voters residing in the City of Point have submitted a petition to the Rains County Commissioners Court requesting that a special election be ordered to fill the unexpired terms of Council Place 1, Council Place 2, and Council Place 4; and

WHEREAS, pursuant to applicable provisions of Texas law, the County Judge of Rains County is authorized and required to order a special election under these circumstances;

NOW, THEREFORE, BE IT ORDERED BY THE COUNTY JUDGE OF RAINS COUNTY, TEXAS, as follows:

1. A special election is hereby ordered for the purpose of filling the following vacant offices on the City Council of the City of Point, Texas:
 - Council Place 1 - unexpired term ending November 2026
 - Council Place 2 - unexpired term ending November 2027
 - Council Place 4 - unexpired term ending November 2027
2. The special election shall be held on May 2, 2026, being a uniform election date authorized by law.
3. Early voting by personal appearance will be conducted from April 20, 2026, to April 28, 2026. During early voting, a voter may vote at any of the locations listed below.

4. Candidate Applications

Applications for a place on the ballot for the offices of City Council Place 1, City Council Place 2, and City Council Place 4 for the City of Point, Texas shall be filed with the filing authority as follows:


