

# **Ground Ambulance Membership Plan**

LifeNet offers non-refundable, non-transferable ground ambulance membership plans within our service areas. New members can join at any time, with coverage starting seven days after application and lasting for one year from the purchase date. Renewing members receive a \$5 discount on the listed prices. Membership includes the following benefits.

### **Reduced Costs**

Your LifeNet Membership provides a convenient way to reduce insurance deductibles and eliminate co-payments, which are often significantly higher than the cost of an annual membership. Uninsured members or those whose transports do not meet their insurer's medical necessity requirements receive a 40% discount on billed charges and are responsible only for the discounted amount. Please note, LifeNet Membership is not insurance. Medicaid patients already receive covered ambulance services and do not need to enroll in a LifeNet Ground Ambulance Membership Plan.

#### **Support Your Community**

Your support helps us offer free educational outreach programs throughout our community. In fact, \$5 from your renewal goes into our Automated External Defibrillators (AED) fund. This fund allows us to provide matching grants for AEDs throughout the community. Grant applications can be found on our website at <u>www.lifenetems.org</u>.

## **Service Areas**

LifeNet Ground Ambulance Membership covers emergency and non-emergency transportation to healthcare facilities within LifeNet's service area when alternative transportation is medically inappropriate. Physician documentation is required to confirm medical necessity for nonemergency transports. LifeNet cannot respond to calls outside its service areas, and membership plans apply only to transportation provided by LifeNet. The chart below details available membership plans by county in Arkansas and Texas.

### \*Medically necessary ambulance transports include:

- Interfacility transports for higher level care
- Non-emergency roundtrip nursing home transports to or from the hospital
- Up to 500 miles for ground ambulance transports
