## **A Motion to Adopt Resolution 25-04**

**Moved:** The Governing Body of the City of Benton adopt Resolution 25-04, Stearman Estates (attached).

## RESOLUTION NO. 25-04

A RESOLUTION GUIDING THE EXPENDITURE OF A FORMULATED PORTION OF GENERAL FUNDS LABELED AS STREET IMPROVEMENTS TO THE STEARMAN ESTATES HOMEOWNERS ASSOCIATION.

**WHEREAS**, street reserves within the Stearman Estates Addition are private streets owned and maintained by the Stearman Estates Homeowners Association, and;

**WHEREAS**, from time to time, these streets are used by the City of Benton to provide certain public services to Stearman Estates residents, and;

**WHEREAS**, the Benton City Council wishes to pecuniarily assist the Stearman Estates Homeowners Association with their maintenance responsibility as prescribed by a formula, and:

**WHEREAS**, this formula will be as follows:

Percent of General Fund Budget assigned to Street Improvements as approved by City Council during the formal budgeting process times the collective amount taxed for the same year to the property owners of Stearman Estates 1 Addition equals the monetary contribution from the City of Benton to the Stearman Estates Homeowners Association, and;

**WHEREAS**, this disbursement will be made after the second distribution of tax dollars prescribed by KSA 12-1678a by Butler County to the City of Benton, usually by or before July 1st of the fiscal year, and;

**WHEREAS**, continuance of this Resolution will be contingent upon Stearman Estates Homeowners Association providing the City of Benton an accounting of receipts and expenditures for auditing purposes at the end of each fiscal year, and;

**WHEREAS**, this Resolution does not bind future Councils from altering or eliminating this disbursement.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BENTON, KANSAS, that disbursement of General Funds shall be expended as this Resolution prescribes.

July 5<sup>th</sup>, 10:00 a.m. to 10:00 p.m.

**SECTION 3.** This resolution shall take effect upon its passage by the Governing Body.
