John Traynor, Carefree - Commented on the Economic Development Plan. Commented their was a "blind eye" to the cost of a resort. Should be open to scrutiny. Comments on signage costs.

Jan Neal, Carefree - Residents are working on a General Plan. Commented on the N.W corner resort development. Stated it is premature to address the Economic Development Work Plan.

Kathlina Lai, Carefree - Urged Council not to approve the Economic Development Plan. Urged the Council not to approve a resort as it will destroy the tranquility of Carefree. Approve the General Plan first.

Maureen Benedetto, Carefree - Questioned why there is a vote on an Economic Development Plan. Do not approve the Economic Development Plan. Change reference to a resort to "boutique" resort.
