## **ORDINANCE NO. 2007-07**

AN ORDINANCE OF THE TOWN OF CAREFREE, ARIZONA, AMENDING SECTION 4-6 OF THE TOWN CODE OF THE TOWN OF CAREFREE, ARIZONA, TO REVISE SECTION A THEREOF AND DECLARING THAT THE IMMEDIATE OPERATION OF THE PROVISION OF THIS ORDINANCE IS NECESSARY FOR THE IMMEDIATE PRESERVATION OF THE PUBLIC PEACE, HEALTH AND SAFETY, THAT AN EMERGENCY EXISTS, AND THAT THIS ORDINANCE SHALL BE EFFECTIVE IMMEDIATELY AND IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE, ADOPTION AND APPROVAL BY THE MAYOR AND COMMON COUNCIL OF THE TOWN AS REQUIRED BY LAW AND DIRECTING THE TOWN CLERK OF THE TOWN OF CAREFREE TO INCORPORATE THIS AMENDMENT INTO THE TOWN OF CAREFREE TOWN CODE.

BE IT ORDAINED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA, that:

Section 4-6(A) of the Town of Carefree Town Code is hereby amended to read in its entirety, as follows:

Section 4-6: Jail Services Recovery Fee

## A. Payment of Costs of Confinement

1. Any person who is arrested for an offense convicted of a misdemeanor offense within the corporate limits of the Town of Carefree ("Town") and who is incarcerated sentenced to a term of incarceration in the Maricopa County Jail or other facility may be required by the Carefree Municipal Court ("Court") to reimburse the "Town" for the incarceration costs.

This amendment shall be incorporated into Article 4-6 of "The Town Code of the Town of Carefree, Arizona."

BE IT FURTHER ORDAINED the immediate operation of the provision of this Ordinance is necessary for the immediate preservation of the public peace, health and safety; an emergency is hereby declared to exist; and this ordinance shall be effective immediately and in full force and effect from and after its passage, adoption and approval by the Mayor and the Common Council of the Town of Carefree as required by law.

BE IT FURTHER ORDAINED that the Town Clerk of the Town of Carefree incorporate the Amendment set forth herein into the Town Code of the Town of Carefree, Arizona.
