**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE  
TOWN OF CAREFREE, MARICOPA COUNTY, ARIZONA,  
DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION ON  
AUGUST 4, 2020**

**WHEREAS**, the Town Council of the Town of Carefree, Maricopa County, Arizona did cause to be submitted to the qualified electors of the Town at a Primary Election held in and for the Town on the 4<sup>th</sup> day of August, 2020 by an all-mail ballot for the election of a Mayor and six Councilmembers; and

**WHEREAS**, the election returns have been presented to and have been canvassed by the Town Council.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the Town of Carefree, Maricopa County, Arizona, as follows:

Section 1. That the total number of votes cast for Mayor at said Primary, as shown by the poll list, was 1,353.

Section 2. That the total number of votes cast for Council Members was 7,219.

Section 3. That the total number of ballots rejected was 2.

Section 4. That the total number of ballots late was 3.
