

#### **SUMMARY:**

The Town of Carefree received it's first Application for a Bingo License. A bingo license is regulated by the Arizona Department of Revenue and is legal in the state of Arizona for recreational purposes or to allow certain types of nonprofit organizations to generate funds to support their activities. A Class "A" licensee generally obtains a license for recreational and social purposes, returning all gross receipts to the players in prizes. Class "A" licensees cannot exceed \$75,000 per year in gross receipts and are taxed at 2.5 percent of the adjusted gross receipts. That is, the amount left, if any, after paying prizes. All taxes collected from bingo licenses are deposited into the state general fund. If approved, the applicant follows through with the Arizona Department of Revenue for final approval.

#### **TOWN COUNCIL ACTION:**

Appoint Town Clerk, Kandace French Contreras, as delegate of the local governing body and approve the application of Patricia Petox-Martelly of Happy Fitness with Patricia, LLC to conduct live Bingo in the Sanderson Lincoln Pavilion one afternoon a week for a period of one year.

#### Parking

#### **SUMMARY:**

Each year, at the conclusion of the annual audit, the Town Clerk submits the current year's expenditure limitation report (ELR) to the State Auditor General together with a form designating the Town Clerk as the Chief Financial Officer (CFO) for that purpose.

Arizona Revised Statutes §41-1279.07(E) requires each county, city, town, and community college district to annually provide the Auditor General the name of the CFO the governing body designated to officially submit the current year's expenditure limitation report (ELR) together with documentation of the governing body's official designation authorizing the individual (by name) to submit the ELR as the CFO. Acceptable supporting documentation includes:

- A signed, governing body-approved resolution.
- Adopted governing body meeting minutes.
- A governing body-approved job description or employment contract that lists preparing and filing the ELR as a job duty. However, the supporting documentation must include the governing body's approval of the individual in that position.

For the purpose of designating the Town Clerk as the CFO, the issuance of the attached Resolution is most practical and falls within the job description for the Town Clerk/Treasurer.
