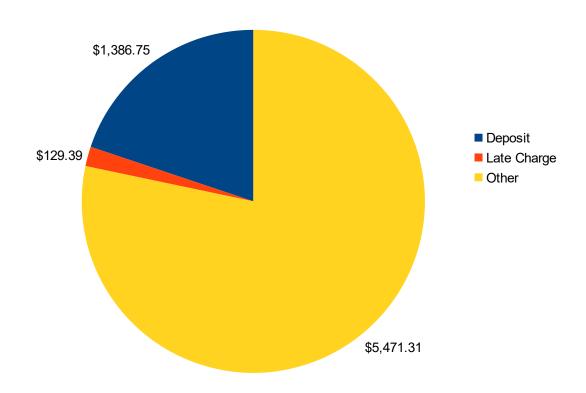

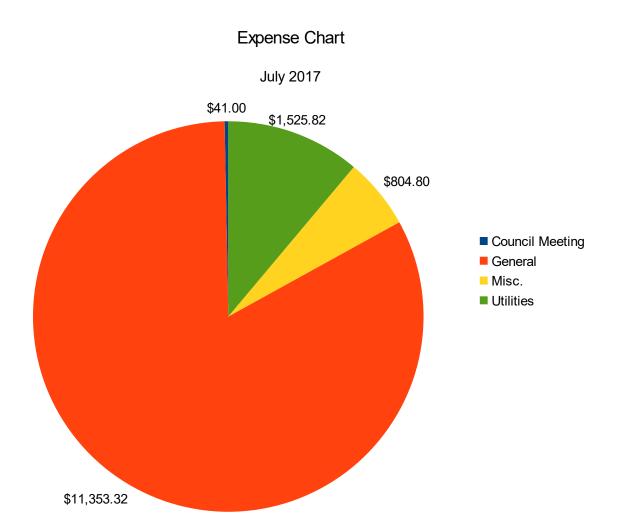

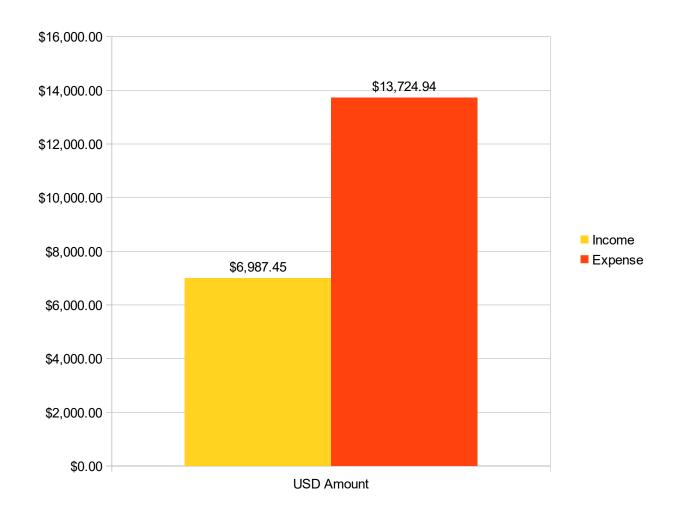

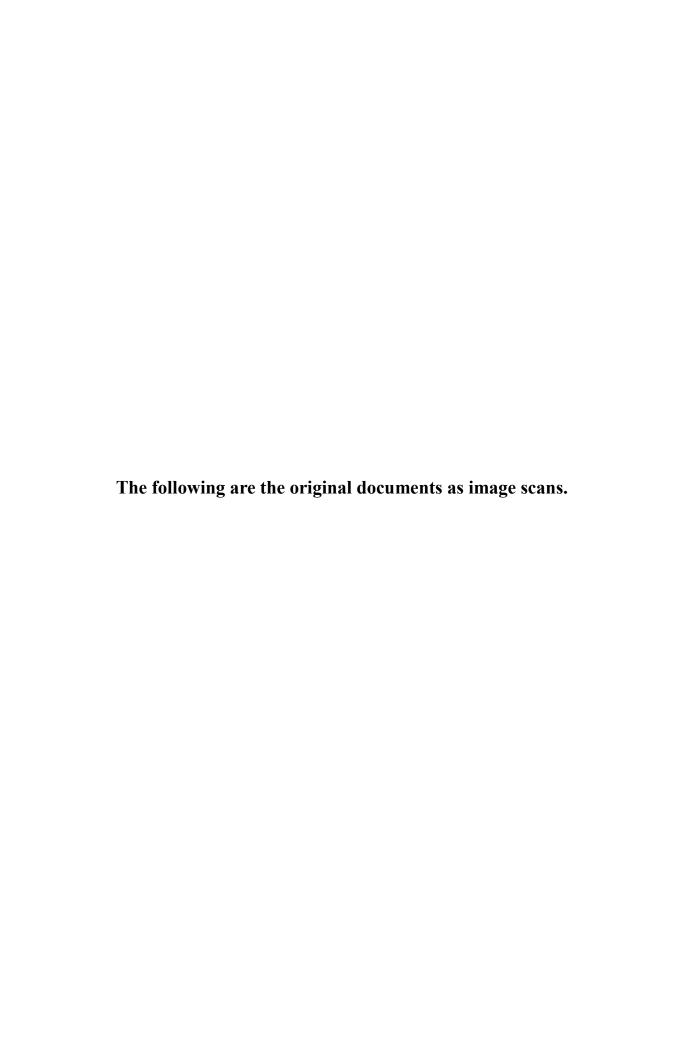


June 2017 Total Income and Expense Chart
