



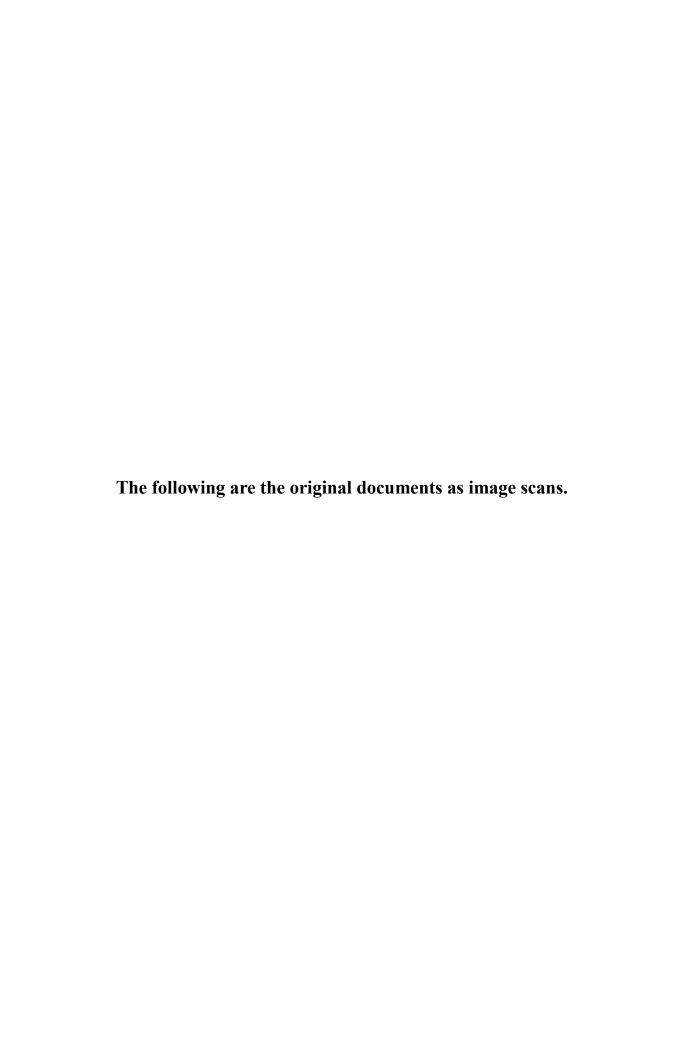


## **September 2017 Total Income and Expense Chart**
