Vendors will also be required to pay a \$5 non-refundable fee. Check, cash, or credit/debit card accepted.
**Vendor spots are limited. We will announce on the City of Slater's Facebook page and website once all vendor spaces have been filled. Alternatively, feel free to call City Hall at 515-685-2531 to check for availability before sending your form and payment.*

Additional Information:

- Electricity is NOT available for vendors.
- The event will be held rain or shine; please use your discretion if inclement weather is expected.
- Market vendors and Junk in the Trunk vendors will be assigned a numbered spot and a map of the vendor locations once their application has been approved and payment has been received.
- Vendors must supply their own table, tent, chair, etc. and stay within their designated space to ensure ease of navigation for customers.
- Each market vendor is responsible for understanding and complying with any licensing requirements through the State of Iowa. The website <https://dial.iowa.gov/licenses/food-hotels/farmers-markets> provides details on foods that do and do not require a license, as well as information on labeling and allergens.
- We welcome youth vendors; however, an adult must be present at the stand.
- The City reserves the right to return any application form and \$5 fee once vendor capacity has been reached.

I would like to reserve a 10 ft wide x 15 ft deep market vendor spots at the 405 Main St. grass lot. Market vendors will have to either park along the gravel alley that borders the lot on the north side or in one of the other parking spots downtown to unload their items. Please DO NOT park on Main St. to unload as those are reserved for the Junk in the Trunk vendors. **If you park in the alley to unload, you will need to move your vehicle to another parking spot downtown after unloading to keep the alley open for emergency vehicles.*

I would like to reserve one of the 24 ft wide x 18 ft deep 'Junk in the Trunk' vendor spots on Main St. These spots are for people who have garage sale items to sell, but would rather not have a garage sale at their house. The space we're offering is TWO angled parking spots parallel to each other; therefore, you will have plenty of room to not only park your vehicle, but also to put items in the parking space beside your vehicle. If you want to utilize a few feet beyond your trunk area and into the street, that's fine as well, but please don't extend too far out into the street to allow enough room for customers to navigate easily. Feel free to bring a tent, table, chair, etc. - as long as your items fit in your space. Additionally, vehicles in these spaces will need to be parked by 7am and won't be able to leave until 11:45am as street barricades will be in place. Please plan accordingly.
