Hometown Heroes of East New Market Qualifications and Rules for Banners

1. Having been a resident of the incorporated boundaries of ENM for a minimum of 5 years.

2. Honorably discharged veteran of Army, Navy, Air Force, Marines or Coast Guard of the U.S.A.

3. Banners shall be removed and replaced at the discretion of the Town of ENM if they become damaged

4. All banners shall be approved by the town council using the rules set forth in this document.

- 5. A list of the banners, their locations which shall be recognized by the veteran's name and the address of the banner will be kept on file in the town office.
- 6. A good faith effort shall be made to contact those veterans or their family members for participation in the Hometown Heroes of ENM before any banners are installed.

7. An application shall be filled out, which shall be reviewed by the Town of East New Market for verification of residency, location preference and whom shall be paying for said banner(s).

8. If approval is given by the town, it shall be forwarded to HHND for verification of honorable discharge

9. Notification will be made after approval for funds to be collected, then banners will be ordered under the

10. The cost of all banners will be paid with private funds from the Hometown Heroes of North Dorchester, veterans, family members, friends or anonymous parties who wish to contribute to cover the cost of installing banners. All monies shall be paid directly to Hometown Heroes of North Dorchester. Monies may be received by the Town of East New Market on their behalf in the form of a check written to HHND or with cash and a written receipt, with their organization responsible for collecting said monies and applications from town hall.

11. The banners shall maintained by said veteran or family of said veteran with the option to remove or replace with the approval of the Town of ENM. Replacement of hardware shall be at the discretion of

12. All banners shall be installed or removed by a source that the Town of ENM approves.

13. All banners shall be placed on the light or utility poles with the appropriate and approved brackets recommended by the banner manufacturer.

14. All banners shall be placed upon each pole described above at the safest and most visible location not to interfere with pedestrian or vehicular safety.

15. Location of banners, see below:

a) Banner locations will be given priority to residents who are veterans living in town who meet the

b) Location of banner(s) to be placed in front of current or former eligible veteran's home, their family member(s) home or other location in the town limits if not taken by another veteran.

c) Priority of banner(s) location will be in order of length of residency.

16. The Town of East New Market reserves the right to modify the program rules.
