No previously submitted bid will be considered. Successful bidders will be notified by telephone and/or e-mail and will have until **3:00 p.m. on March 28, 2023** to pay for the property by cash or money order and remove their property.

All items are sold "As Is" without warranty. The City retains the right to refuse all bids or withdraw items for sale.

Bid Packets shall be submitted in a **sealed envelope that is clearly labeled with the bidder's name, mailing address, phone number, e-mail address, and titled "Bid Packet: Sealed Bid"** If submitting by mail, the sealed envelope Bid Packet may be placed in an outer mailing envelope or packaging material.

Successful bidders will be notified by telephone and/or e-mail and will have until 3:00 p.m. on March 28, 2023 to pay for the property by cash or money order and remove their property.
