#### **Purpose of Position**

This position exists to perform street, sanitation, sewer and park maintenance and repair activities for all municipal owned properties and equipment.

#### **Essential Duties and Responsibilities**

The following duties are normal for this position. These are not to be construed as exclusive or all-inclusive. Other duties may be required and assigned.

- Performs street, sanitation and sewer maintenance: maintains streets, street signs and lights; collects and hauls yard waste, refuse, leaves and brush; snow and ice control activities; plants, removes and trims public trees; cleans and repairs storm and sanitary sewers; maintains, repairs and re-builds catch basins; maintains street decorations.
- Performs general Public Works duties: performs basic carpentry, concrete, asphalt and vehicle maintenance duties; hauls dirt, snow, gravel; installs & maintains pavement marking, maintains municipal buildings and grounds; assists with surveying and/or construction inspection.
- Assists Parks Maintenance and Utilities Departments with performance of other duties as required.

#### Minimum Training and Experience Required to Perform Essential Job Functions

- High School Diploma or equivalent and one to two years experience or any combination of education and experience that provides equivalent knowledge, skills and abilities. Must be able to possess a valid Wisconsin Commercial Driver's License with air brake and tanker endorsements within 6 months of hire.
- Additional training as necessary to obtain any and all certifications and/or endorsements as required for operation of vehicles and equipment.
