

**ORDINANCE 2022 -3**  
**AN ORDINANCE ENACTING A CODE OF ORDINANCES FOR THE**  
**TOWN OF GREENTOWN REVISING AMENDING RESTATING**  
**CODIFYING AND COMPILING CERTAIN EXISTING GENERAL**  
**ORDINANCES OF THE TOWN OF GREENTOWN**

WHEREAS the present and prior Town Councils of the Town of Greentown have adopted various ordinances which are currently inadequately organized and classified and are insufficient in form and substance for the complete preservation of the public peace, health, safety, and general welfare of the municipality and for the proper conduct of its affairs; and

WHEREAS the Acts of the Indiana legislature empower and authorize the political subdivisions to revise, amend, restate, codify and compile any existing ordinances and all new ordinances not heretofore adopted or published and to incorporate such ordinances into one ordinance in book form; and

WHEREAS the Town Council of the Town of Greentown has authorized a general compilation, revision and codification of the ordinances of the Town of Greentown of a general and permanent nature and publication of such ordinance in book form; and

WHEREAS it is necessary to provide for the usual daily operation of the Town of Greentown and for the immediate preservation of the public peace, health, safety and general welfare of the Town of Greentown that this ordinance take effect at an early date.

NOW, THEREFORE BE IT ORDAINED BY THE TOWN OF GREENTOWN,  
INDIANA, THAT:

SECTION I. The general ordinances of the Town of Greentown as revised, amended, restated, codified, and compiled in the book form are hereby adopted as and shall constitute the “Code of Ordinance of the Town of Greentown, State of Indiana.”

SECTION II. Such Code of Ordinances as adopted in Section 1 shall consist of the following Titles: See attached Table of Contents.


SECTION III. All Ordinances or parts of Ordinances pertaining to the subjects treated in such Code of Ordinances shall be deemed repealed from and after the effective date of this ordinance except as they are included and reordained in whole or in part in such Code; provided, such repeal shall not affect any offense committed or penalty incurred or any right established prior to the effective date of this ordinance, nor shall such repeal affect the provisions of ordinances levying taxes, appropriating money, annexing or detaching territory, establishing franchises, or granting special rights to certain persons, authorizing public improvements, authorizing the issuance of bonds or borrowing money, authorizing the purchase or sale of real or personal property, granting or accepting easements, plat or dedication of land to public use, vacating or setting the boundaries of streets or other public places; nor shall such repeal affect any other ordinance of a temporary or special nature or pertaining to subjects not contained in or covered by the Code.


SECTION IV. Such Code of Ordinances shall be deemed published as of the day of its adoption and approval by the Town Council of the Town of Greentown and the Clerk of the Town of Greentown is hereby authorized and ordered to file a copy of such Code of Ordinances in the Office of the Clerk Treasurer.

SECTION V. Such code shall be in full force and effect as provided in Section 6, and such Code of Ordinances shall be presumptive evidence in all courts and places of the ordinance and all provisions, sections, penalties and regulations therein contained and of the date of the passage, and that the same is properly signed, attested, recorded, and approved and that any public hearings and notices thereof as required by law have been given.


SECTION VI. This Ordinance shall be in full force and effect following its passage by the Town Council of the Town of Greentown and publication as provided by law.



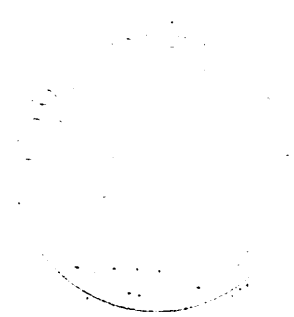
