

ORDINANCE NUMBER 2022-7

AN ORDINANCE AMENDING THE SALARIES OF THE TOWN COUNCIL, CLERK TREASURER, TOWN EMPLOYEES, PLAN COMMISSION, AND THE BOARD OF APPEALS FOR THE TOWN OF GREENTOWN, INDIANA.

BE IT HERBY ORDAINED the salaries herein set forth shall be effective January 1, 2023 and shall be provided for in the budget for the Town of Greentown, Indiana, for the year 2023. Employees are paid semi-monthly for a total of 24 pays.

LONGEVITY PAY AND LUMP SUM BONUS

The Clerk-Treasurer and all other eligible Town employees shall receive longevity pay of \$100.00 for each year of service. Longevity payment will be included in the second payroll in November. A lump sum bonus of \$500 for each employee will be included in the first payroll in November. Employees who have been terminated or resign during the year will not receive longevity or bonuses.






