

**ORDINANCE NO. 2024-3**

**AN ORDINANCE AMENDING THE RATES AND CHARGES  
FOR THE SEWER WORKS UTILITY**

WHEREAS, the Town of Greentown, Indiana ("Town") operates a sewer works utility for the benefit of the citizens and the surrounding area;

WHEREAS, various ordinances have been adopted from time to time regarding policies and procedures for the sewer works and the establishment of sewer rates, fees and charges;

WHEREAS, the existing rates, fees and charges are set forth in the earlier Ordinance, Ordinance No. 2018-1, adopted on March 6, 2018;

WHEREAS, it has been determined by the Town Council that the existing rates are inadequate to fund the sewer works utility, and therefore should be amended and modified as provided for in this ordinance;

NOW, THEREFORE BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GREENTOWN, as follows:


1. SEWER RATES – for use of and service rendered by the sewer works, each user shall be charged in an amount based upon a fee schedule, shown in Appendix A.

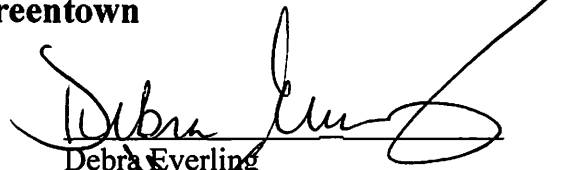
All other provisions of Ordinance No. 2018-1 and earlier ordinances, not amended by this ordinance shall remain in full force and effect.

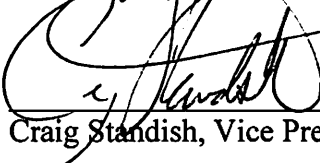
The provisions herein, when approved and adopted, shall be effective as soon as practicable.

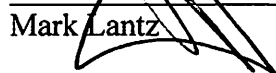

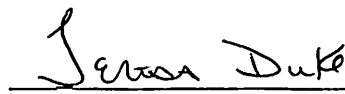
