

ORDINANCE NUMBER 2024-7

AN ORDINANCE AMENDING ORDINANCE 2023-5 THE SALARIES OF THE TOWN COUNCIL, CLERK TREASURER, TOWN EMPLOYEES, PLAN COMMISSION, AND THE BOARD OF APPEALS FOR THE TOWN OF GREENTOWN, INDIANA.

BE IT HERBY ORDAINED the salaries herein set forth shall be effective the first payroll in 2025 and shall be provided for in the budget for the Town of Greentown, Indiana, for the year 2025. Employees are paid semi-monthly for a total of 24 pays.

In addition to the above salaries, the Town Council President is eligible to receive the same insurance benefits as full-time employees as set forth in the Town of Greentown Personnel and Employee Benefits Policies.

LONGEVITY PAY AND LUMP SUM BONUS

The Clerk-Treasurer and all other eligible Town employees shall receive longevity pay of \$100.00 for each year of service. Longevity payment will be included in the semi-monthly payroll. A lump sum bonus of \$600 for each employee will be included in the first payroll in November. Employees who have been terminated or resign during the year will not receive bonuses.




