

**CITY OF COOLIDGE, TEXAS
REQUEST FOR QUALIFICATIONS
PROFESSIONAL ENGINEERING SERVICES**

The City of Coolidge, Texas, is seeking statements of qualifications from qualified professional engineering firms to provide engineering services pursuant to Texas Government Code Chapter 2254.

The selected firm will provide engineering services in connection with water system infrastructure improvements, including:

- Evaluation and design of a new high-density polyethylene (HDPE) transmission line (approximately five miles) to convey water from Bi-Stone Water Supply Corporation to the City of Coolidge;
- Decommissioning of an existing 8-inch transmission line;
- Rehabilitation of water storage facilities, including a ground storage tank, standpipe, and elevated storage tank;
- Replacement of aging distribution system piping; and
- Funding assistance, permitting, bidding, and construction phase services.

Firms must demonstrate experience with municipal water system improvements in Texas and familiarity with applicable state and federal funding programs.

Evaluation Criteria:

Firms will be evaluated and ranked based on demonstrated competence and qualifications, including: (1) experience with similar municipal water infrastructure projects; (2) experience with state and federal funding agencies and grant or loan administration; (3) qualifications and experience of key personnel assigned to the project; (4) capacity to perform the work within required timelines; and (5) record of past performance and professional references. Pricing information shall not be submitted and will be negotiated with the top-ranked firm in accordance with Texas Government Code Chapter 2254.

The City of Coolidge, Texas, is seeking qualified certified public accounting firms to provide professional accounting services pursuant to Texas Government Code Chapter 2254.

The selected firm or firms will be engaged to:

1. Review and evaluate the City's financial records, accounts, and fund balances; assist with reconciliation and clean-up of accounting records; and prepare the City for audit readiness; and
2. Perform annual financial audits for fiscal years 2023, 2024, and 2025, with all audit reports to be completed on or before June 30, 2026.

Interested firms must demonstrate experience in municipal governmental accounting and auditing in Texas. Firms qualified to perform Single Audits under applicable federal standards should indicate such qualifications if applicable.
