All bills are due and payable the **15<sup>th</sup>** of each month. A 10% late fee will be applied on the 16<sup>th</sup> of the **month**. Accounts not paid in full, by the **15<sup>th</sup> will be disconnected the Monday following the 15<sup>th</sup> with** <u>no</u> <u>exceptions.</u> If disconnected the full amount and reconnect fee must be paid in full before services will be restored without exception. ### **General Information**

- City Hall is located at 9911 North Main Street in Nahunta, GA. Our office hours are 8:00 a.m. to 4:30 p.m. Monday thru Friday
- > All City utility bills are due by 4:30 pm on the 15<sup>th</sup> of the month.
- A 10% late fee will be applied to all accounts not paid in full the morning of the 16<sup>th</sup> of the month.
- Please include your account number or payment stub with your payment to ensure proper credit is applied to your account.
- Cash, money order, check (return check fee is \$35.00), Visa, MasterCard and Discover are all approved payment methods (please note that all payments made with a card are subject to a service fee).
- Payments can be made in person at City Hall during office hours. Payments can also be mailed to P.O. Box 156 Nahunta, Ga 31553, or you can pay by phone using your credit/debit card.
- > An after-hours drop box is located in front of City Hall for check and/or money order payments outside of normal business hours.
- If you would like to set up an auto-payment with your debit or credit card you will need to complete the form. Auto-Payments are processed on the 1<sup>st</sup> or 15<sup>th</sup> of the month. In the event the 1<sup>st</sup> or 15<sup>th</sup> falls on a day we are closed, we will process the payment the next business day.
- Non-payment by the immediate Monday following the 15<sup>th</sup> will result in disconnection, this means that if the 15<sup>th</sup> of the month is on a Sunday, Monday the 16<sup>th</sup> is the disconnect date, NO EXTENSIONS WILL BE ALLOWED.
- Services disconnected for non-payment of bill will be restored only after the bill is paid in full, such security deposit as may be required by the mayor and Council is made, and a reconnection fee is paid, \$50.00 for reconnection from 8:00 am to 3:00 pm, \$75.00 3:00 pm to 4:30 pm. No exceptions. Reconnections will be scheduled for the following business day after payment is made in full.
- A notice of no less than three (3) days must be given in person, in writing, at the Nahunta City Hall in order to discontinue or transfer services. The outgoing party shall be responsible for all water consumed up to the time of departure or the time specified for departure, whichever period is longer. The new occupant shall apply for service within forty-eight (48) hours of occupying the premises. Failure to do so will make him/her responsible for all consumption since the last meter reading.
- Trash is picked up on Fridays. It is advisable to place the can(s) by the road Thursday night as the pickup usually occurs very early.
