Dear Jerome Business Owner,

During these very difficult times we wanted to make you aware of resources that are available for your business, your employees, and you as the business owner. Please note that the resources continue to be expanded. Following are services and programs that are available to you whether you are a for-profit business or a non-profit organization.

Program Overview: An overview of loans and an advance available to small businesses is attached for your use. Up to date information can be found on the Yavapai College SBDC website - https://www.yc.edu/v6/small-business-development-center/

Economic Injury Disaster Loan (EIDL): Businesses with less than 500 employees are eligible to apply for SBA loans.

- Long Term and Low Interest: 30-year loans at 3.75 percent for businesses and 2.75 percent for non-profits
- Available for six months of business expenses
- Grant funds of \$10,000 available for business expenses
- No collateral required for loans under \$25,000
- Once you apply you will be contacted within five days to discuss your request

Paycheck Protection Program: Small businesses can obtain funds to pay for up to 8 weeks of payroll costs. The assistance is in the form of a loan but if certain criteria are met, these funds will be forgiven.
