



Subtraction Meter Notes

March 3, 2017

A subtraction meter may be installed by any customer who has both water and sanitary sewer service provided by the FCWSA. The purpose of a subtraction meter is to negate the sewer charge for water used by the customer which will not enter the sanitary sewer system (i.e. water for an irrigation system or yard hydrant.)

Permitting Notes

- Submit a Request for Plumbing Permit Release (DSVC-0012), Fixture Count Worksheet (ENGR-0005 or ENGR0006), and if applicable additional water availability fee and meter fee to the FCWSA. The Fixture Count Worksheet will determine what your primary meter size will be with the new addition of water fixtures.
- When all applicable fee and forms are submitted and approved, the FCWSA will issue a Plumbing Permit Release.
- Submit the Plumbing Permit Release to Fauquier County Community Development.
- Community Development will issue a building permit.

Construction Notes

- Subtraction meters are owned and maintained by the customer.
- The subtraction meter installation shall be inspected by a Fauquier County Inspector.
- The customer is wholly responsible for the construction of the meter crock and installation of the meter. The FCWSA does not provide materials or labor.
- The installation shall conform to detail sheet WM-06.
- The subtraction meter shall be a 5/8"x3/4" Neptune T-10 with expansion nut and R-900 RF Radio Read.
- The water line material is to be SDR-9, CTS, 200psi, HDPE pipe. Ford pack joints with stainless steel inserts are to be used at all water line connections.
- It is the responsibility of the customer to provide the proof of final inspection from the Building Office to the FCWSA upon installation.
- The FCWSA will get the meter ID from installed subtraction meter.
- The FCWSA will not adjust bills until provided with the final inspection and meter ID is obtained.



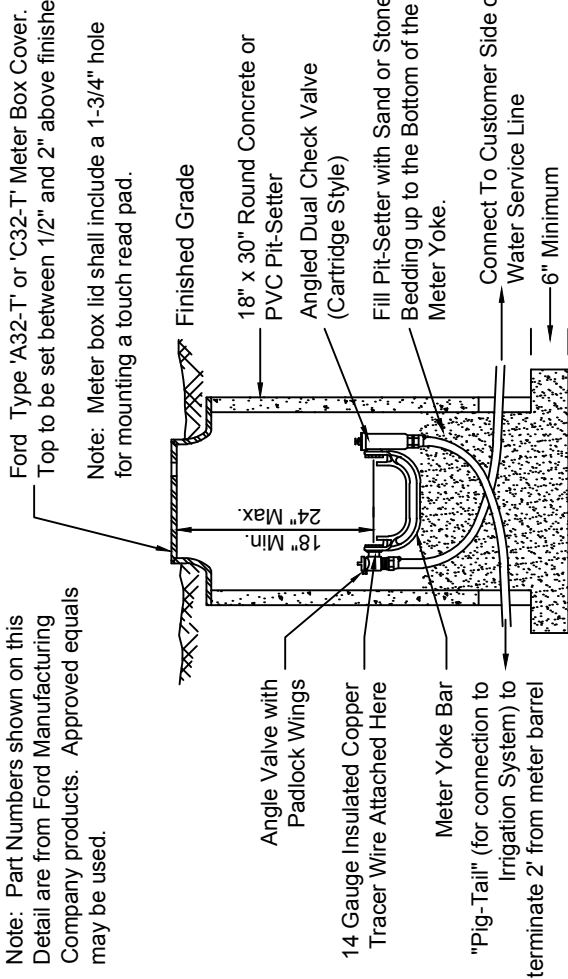

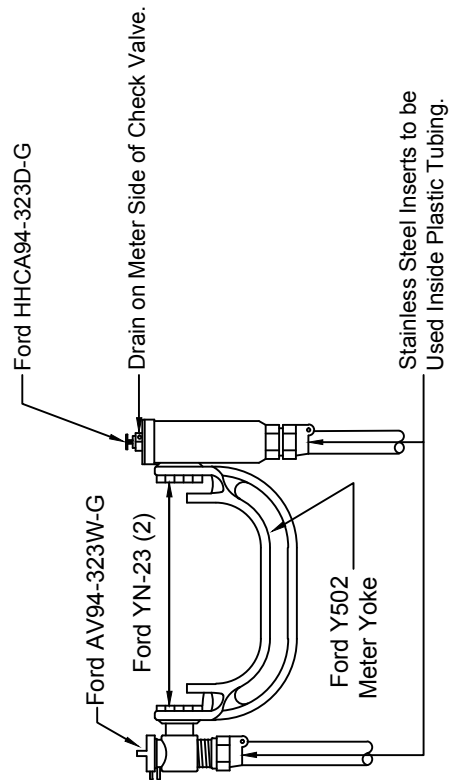

Meter Box Detail

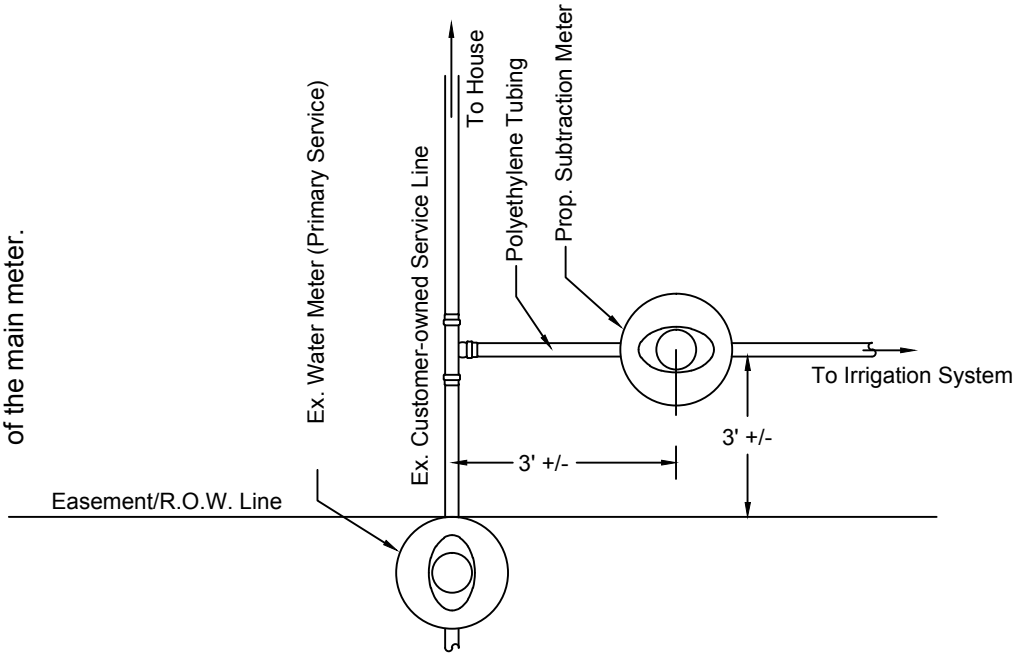
for 5/8" x 3/4" Water Subtraction Meter

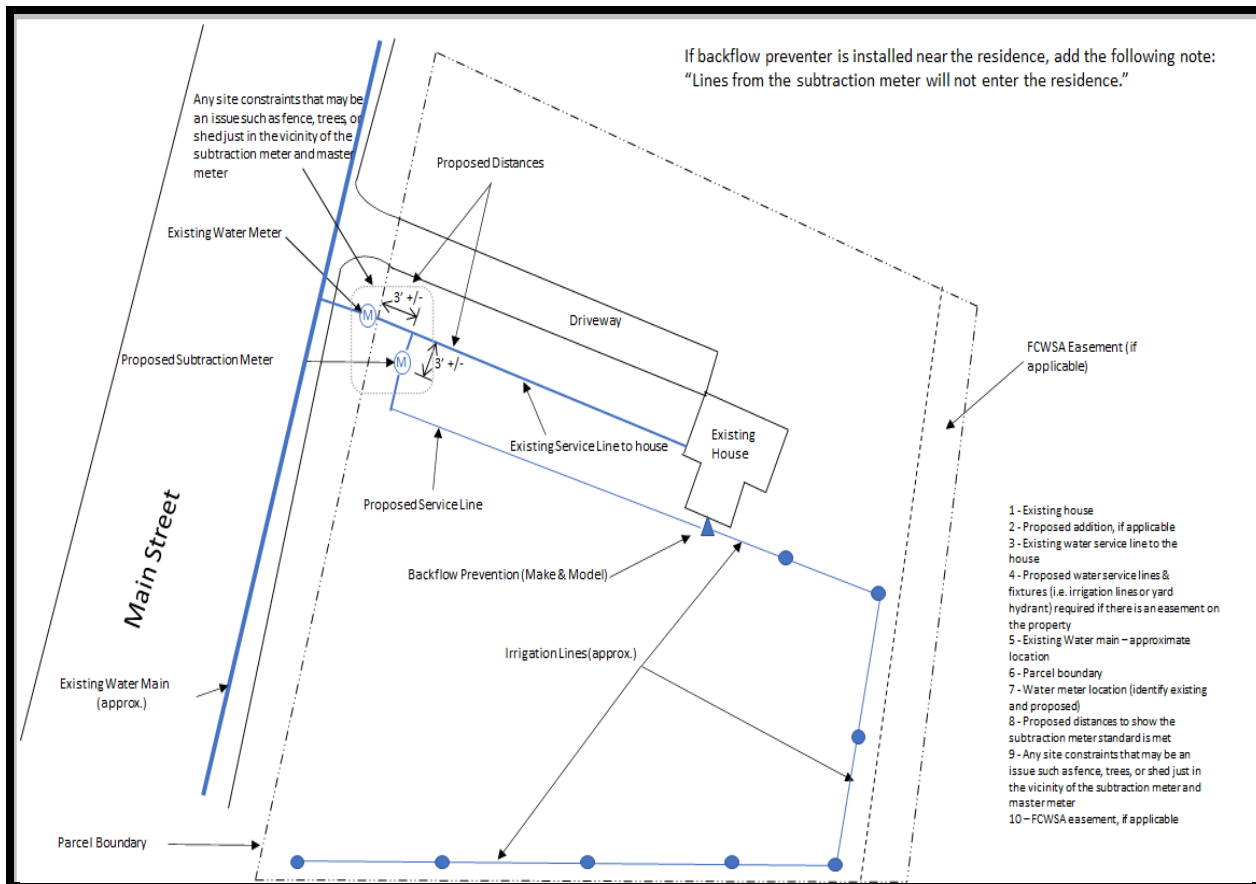

REQUEST FOR PLUMBING PERMIT RELEASE

As the Contractor and/or Owner are applying for a plumbing permit to modify the interior/exterior plumbing of the affected property, the Authority's service capacity allocation (meter size) to the property may be increased in accordance with the procedures of the Authority's Rules and Regulations. Should such an increase occur, the Authority will assess a Supplemental Availability Fee to the property for the increase in meter size. Further, should the quarterly and/or annual usage limits allowed for a particular meter in accordance with the Authority's Schedule of Rates, Fees and Other Charges be exceeded, the Authority will assess a Supplemental Availability Fee to the property for the increase in meter size resulting from the property's increased service demand.
